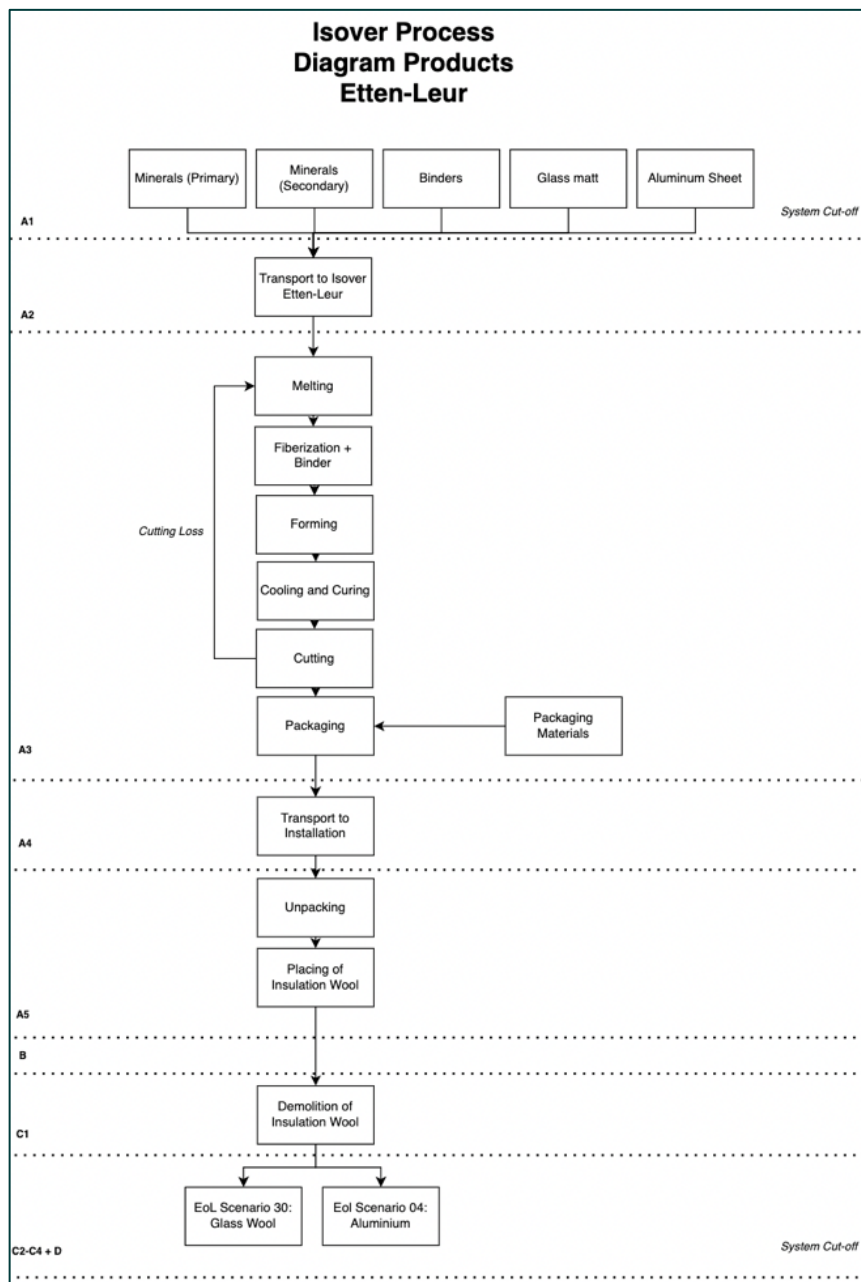

Detailed Product Description

General Product Information

Rigid, shape-retaining glass wool board for thermal insulation of cavity walls. The product is finished on the front with a specially coated and perforated aluminum reflective foil for optimal insulation performance.

Environmental product declaration per m² based on glass wool component thickness of 139 mm, in which glass wool component is scalable on thickness (in mm). Total weight of product is 3,069 kg/m². Weight of scalable component is 2,919 kg/m². Lambda-value of product is 0,034 W/m*K. R-declared-value is 4,08 m²·K/W. Reference service life is 75 years.

This EPD is a component based EPD, as is explained in the section “EPD Application” below.

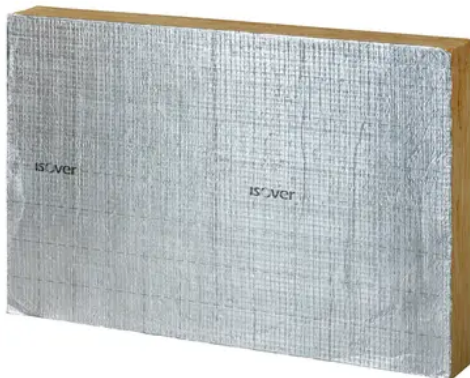


Figure: Representation of product

EPD Components

Result Calculation
