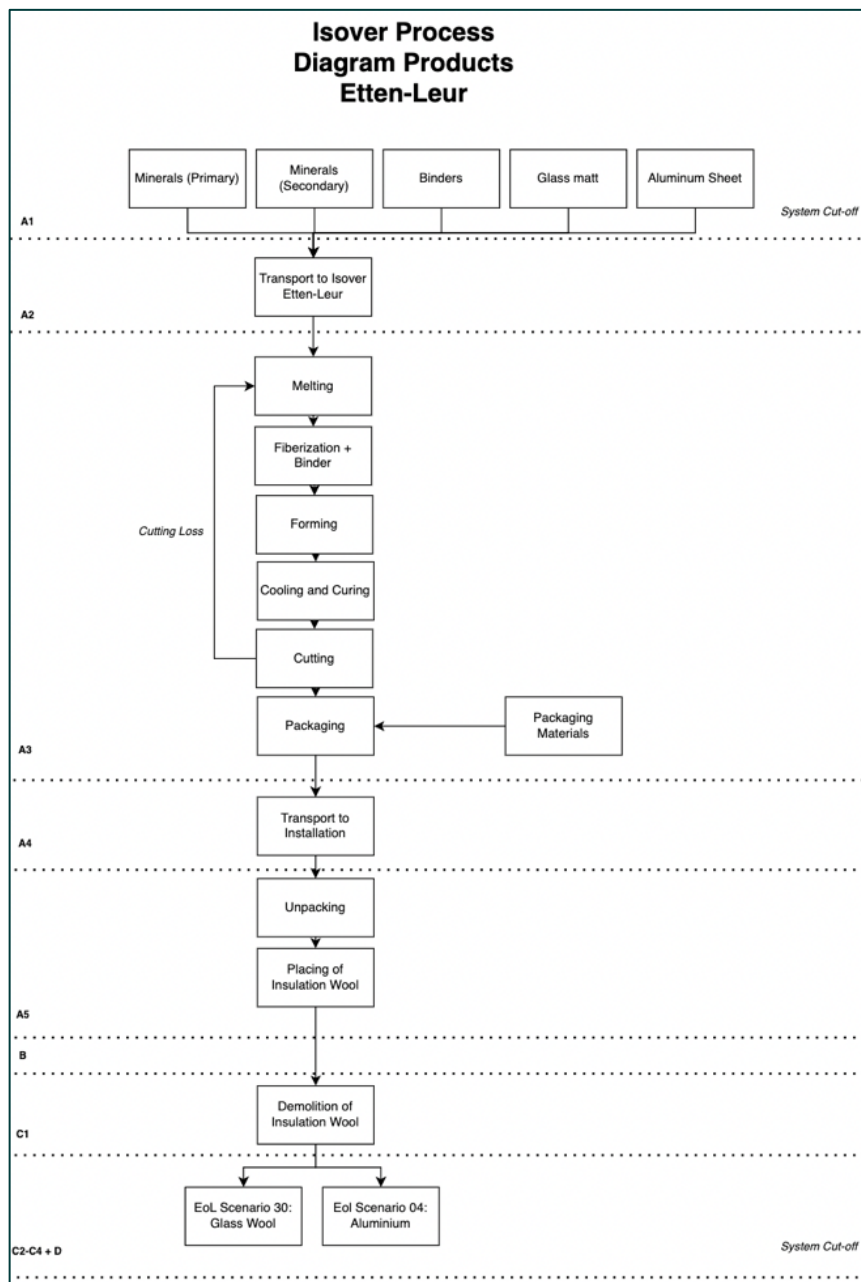

Detailed Product Description

General Product Information

Shape-retaining glass wool board faced on both sides with special glass fleece for fire-safe, acoustic and thermal insulation of façade systems and curtain walls.

Environmental product declaration per m² based on glass wool component thickness of 160 mm, in which glass wool component is scalable on thickness (in mm). Total weight of product is 4,872 kg/m². Weight of scalable component is 4,752 kg/m². Lambda-value of product is 0,032 W/m*K. R-declared-value is 5 m²·K/W. Reference service life is 75 years.

This EPD is a component based EPD, as is explained in the section “EPD Application” below.

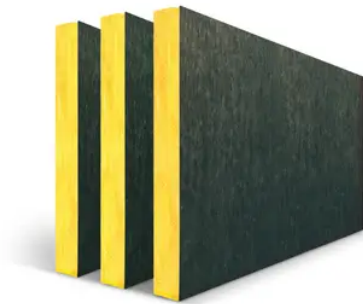


Figure: Representation of product

EPD Components

Result Calculation

EPD product specific results can be calculated on the base of this document by following the formula below.
