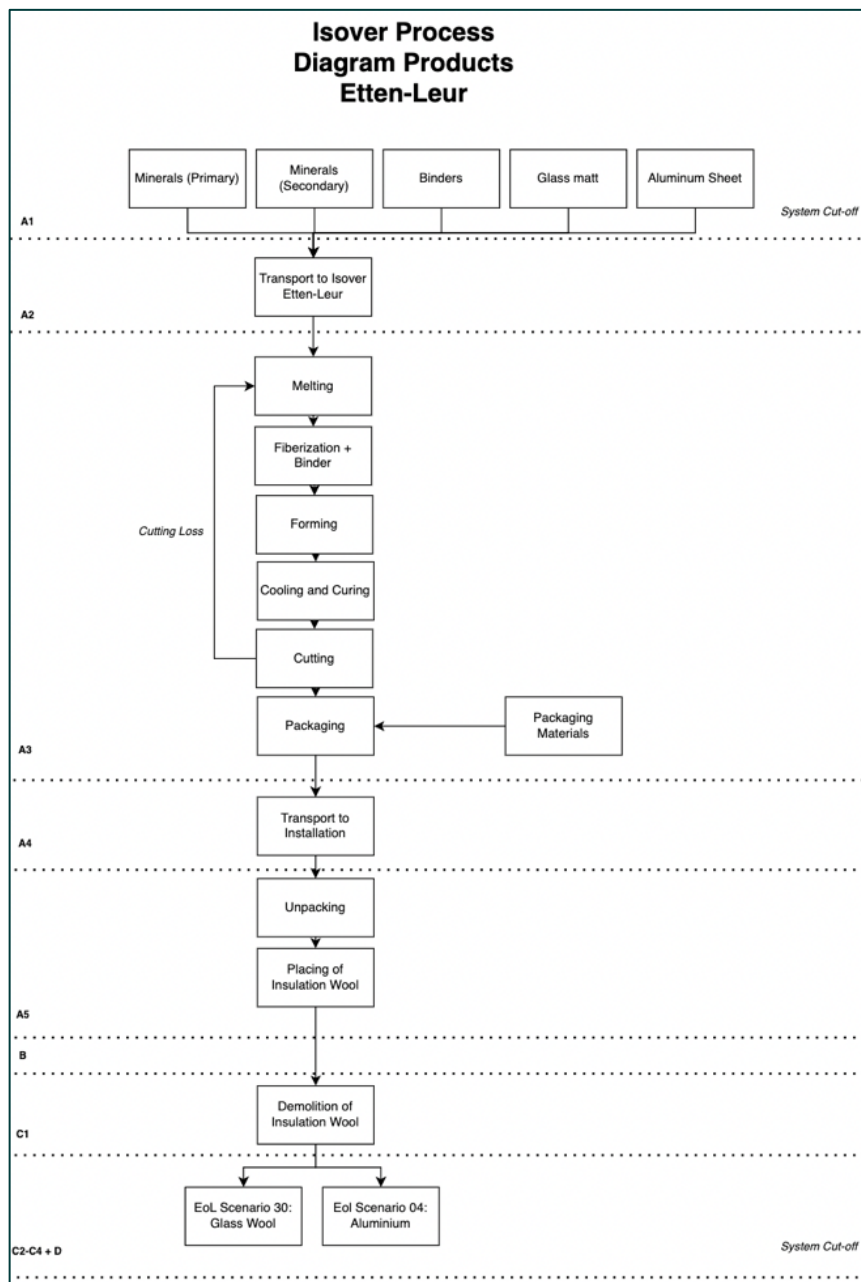

# Detailed Product Description

## General Product Information

Rigid, unfaced glass wool blanket for fire-safe, thermal and acoustic insulation of timber frame roof and façade elements.

Environmental product declaration per m<sup>2</sup> based on glass wool component thickness of 245 mm, in which glass wool component is scalable on thickness (in mm). Total weight of product is 5,88 kg/m<sup>2</sup>. Weight of scalable component is 5,88 kg/m<sup>2</sup>. Lambda-value of product is 0,033 W/m\*K. R-declared-value is 7,4 m<sup>2</sup>·K/W. Reference service life is 75 years.

This EPD is a component based EPD, as is explained in the section “EPD Application” below.

## EPD Components

## Result Calculation
